The Philippine Racing Commission (PHILRACOM) through the Trust Fund intends to apply the sum of One Million Five Hundred Thousand Pesos (Php 1,500,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for Equine DNA Testing and Parentage Validation. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The Philippine Racing Commission (PHILRACOM) now invites bids for Equine DNA Testing and Parentage Validation. Delivery of the Goods is required within thirty (30) days upon receipt of Notice to Proceed. Bidders should have completed, within the last two (2) years from the date of submission and receipt of bids, a contract similar to the Project. (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

- 4. Interested bidders may obtain further information from PHILRACOM-BAC Secretariat and inspect the Bidding Documents at the address given below during 9:00 A.M. 4:00 P.M. Monday to Friday, until its closing period posted in the PhilGEPS.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders on August 26, 2021 from the address below and upon payment of a non-refundable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand Pesos (Php 5,000.00).

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

- 7. Bids must be duly received by the BAC Secretariat at the address below on or before March 8, 2022 at 9:00 AM All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18

Bid opening shall be on March 8, 2022, 10:30 A.M at PHILRACOM Board Room, Legaspi Village, Makati City. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

Please be reminded that unless otherwise advised by the GPPB, starting May 01, 2017, bidders are required to submit their PhilGEPS Certificate of Registration of Membership under Platinum Category (Section 25.2 (b) RIRR of RA No. 9184 in relation to GPPB Resolution No. 03-2016 dated October 27, 2016).
