TERMS OF REFERENCE

PROCUREMENT OF NEW COMPUTER UNITS (LAPTOP)

I. Background

As part of a 5-year plan to improve the quality of services provided by the Philippine Racing Commission (PHILRACOM) to its stakeholder, PHILRACOM aims to increase its work productivity and efficiency by procuring new and state-of-the art IT infrastructures and equipment.

II. Justification

The current ICT equipment situation of PHILRACOM, as per the inventory conducted by the office and with the support of the IT team, showed that most of the desktops, laptop, and other ICT peripherals are beyond its maximum normal and reliable life span with some equipment as old as 5 years which has render to be non-functional, beyond repair, obsolete and could not meet the demand of the workload and the current software technology. This may cause, among others, breakdown of equipment that can result in data loss and hamper the office's operations.

III. Objective

To provide efficient and reliable delivery of service to the different stakeholders and the general public, PHILRACOM will acquire functional and working ICT equipment, to aid the different operating units in the performance of its

functions.

IV. Approved Budget for the Contract (ABC)

The approved budget for the contract is One Million Five Hundred Twenty Thousand Pesos (PHP 1,520,000.00) sourced from the 2022 Capital Outlay, inclusive of all applicable government taxes and charges.

V. Supplier's Qualifications

- 1. The bidders should have been operating in the Philippines for at least three (3) years and is registered with the Securities and Exchange Commission or Department of Trade and Industry.
- 2. The bidders must be PHILGEPS registered.

VI. Scope of Services

The Supplier shall provide the following:

- 1. Supply of 1-Lot (40-units) of Laptop Computers.
- 2. Delivery of the laptops at the PHILRACOM main office- 4th Floor Electra House Building, V.A. Rufino St. Legaspi Village, Makati City. Delivery shall be free of charge.

VII. Technical Specifications

The majority of the laptop to be used is intended for field work and on-site transactions outside the office. It is expected that the provided items can withstand the effects of difficult environmental conditions.

VIII. Other Requirements

- 1. Three (3) months warranty on items.
- 2. Telephone and/or online after-sales support shall be provided by the supplier within 24-hours from verbal/written notification of PHILRACOM
- 3. Within the warranty period, items that cannot be repaired within forty-eight (48) hours shall be immediately replaced with a new item of similar specifications or better at no cost to PHILRACOM.

IX. Delivery

All forty (40) units of laptops shall be delivered to the PHILRACOM office within a period of fifteen (15) working days upon receipt of the Notice to Proceed.

X. Payment

Payment shall be made within fifteen (15) working days upon complete delivery of all items.

XI. Mode of Procurement

The Procurement of New Computer Units (Laptop) shall be undertaken through Public Bidding

XII. Performance Security

To guarantee the faithful performance by the winning Bidder of its obligations under the contract, it shall post a performance security as required under Section 39 of the Revised IRR of RA 9184 prior to signing of contract. The Performance Security shall be denominated in Philippine Pesos and posted in favor of the PHILRACOM, which shall be forfeited in the event it is established that the winning bidder is in default in any of its obligations under contract.

XIII. Language of Bid

The Bid, as well as all correspondence and documents relating to the Bid exchanged by the Bidder and the PHILRACOM, shall be written in English.

XIV. Bidding Documents

interested bidders at the 4th Floor Electra House Bldg. Esteban St., Legaspi Village, Makati City, upon payment of a non-refundable fee in the amount of Five Thousand Pesos (Php 5,000.00).
